


How did the Fund perform in the period?

From inception of 10/2/2024 through the period ended 9/30/2025, the 3EDGE Dynamic Fixed Income ETF, ticker: EDGF, (the "Fund") returned 2.11% on a total return basis (with dividends reinvested) net of fees and expenses. While the Fund does not have a benchmark, the Bloomberg U.S. Aggregate Bond Index is a reasonable proxy for comparison which returned 2.79% over the same time period. The Fund's allocation to high quality US Treasuries along with exposures to shorter-term bonds over this period contributed to relative underperformance. The firm's research suggested the potential for increases in Treasury yields which would result in capital losses if the funds duration were longer. The Fund's indicated yield was 3.26%.



Householding
